**DECISION
on the Establishment and Election of
the Executive Committee of the Assembly
of the Serbian People in Foča****Article 1**

4. Milojica MILETIĆ, Secretary for National Defence;
5. Vukašin PERIŠIĆ, Director of Surveying and Legal Property Affairs.

This Decision shall enter into force on the day it is adopted and shall be published in the *Official Gazette of the Serbian People in Bosnia and Herzegovina*.

Where it is not possible to convene a session of the Assembly of the Serbian Municipality of Foča, the Crisis Staff shall take decisions falling within the competence of the Assembly during a state of war, imminent threat of war or state of emergency.

This Decision shall enter into force on the day it is adopted and shall be published in the *Official Gazette of the Serbian Municipality of Foča*.
