We hereby inform you that at the Bajina Bašta KPDG SM official premises, at 1400 hours on 23 July 1995, we handed over the following persons and items to the Bratunac KPDG SM Skelani branch:

1. Hariz IBRAHIMOVIĆ son of Ćemail, born 17 October 1961 in Skelani, , last place of residence Srebrenica. In addition to his clothes he had DM 170 in the following currency denominations: 1 x 100, 1 x 50 and 1 x 20, and 210 FRY new dinars in the following currency denominations: 10 x 20 and 2 x 5;
2. Hazim IBRAHIMOVIĆ, son of Ćemail, born 9 May 1965 in Skelani, , last place of residence in Srebrenica. Except for his clothes he had no luggage or personal identification papers;
3. Fahidin IBRAHIMOVIĆ, son of Ćemail, born 20 October 1965 in Skelani, last place of residence in Srebrenica. In addition to his clothes he had identity card no. 1693 issued in his name by the Srebrenica SUP /Secretariat of the Interior/.
4. Abdurahman MALKIĆ son of Rušid, born 11 June 1954 in Poznanovići, last place of residence in Srebrenica. In addition his clothes he had 100 DM in the following currency denominations: 1 x 50, 2 x 20 and 1 x 10, one 100 Swiss franc note, a 7.65 mm calibre *Zastava* pistol, serial no. /?C/-109475, with a magazine of seven bullets of the same calibre, identity card no. 654/83 issued by the Srebrenica SUP and passport no. BH 650059, issued in his name by the Srebrenica SUP;
5. Hamdija MALKIĆ, son of Rušid, born 8 June 1958 in Poznanovići, last place of residence in Srebrenica. In addition to his clothes he had 255 DM in the following currency denominations: 1 x 100, 3 x 20 and 9 x 10 and 1 x 5, a 7.62 mm calibre *Zastava* pistol, serial no. 0-272885, with a magazine of eight bullets of the same calibre, identity card no. 1654/87 issued by the Srebrenica SUP and driver's licence no. 3013, issued in his name by the Srebrenica SUP;

6. Hamza MALKIĆ, son of Hakija, born 25 April 1964 in Poznanovići, last place of residence in Srebrenica. In addition to his clothes he had a 6.35 calibre *Zbrojovka* pistol, serial no. B-263255 with a magazine of five bullets; 620 DM in the following currency denominations: 6x 100 and 1 x 20; 10 (ten) gold ladies' rings of various shapes and sizes; one pearl necklace; identity card no.309/86 issued by the Srebrenica SUP and driver's licence no. 3402 issued by the Srebrenica SUP in his name.
7. Sadik SALIHOVIĆ, son of Hakija, born 26 June 1965 in Srebrenica, last place of residence in Srebrenica. In addition to his clothes he had a 7.65 calibre *Zastava* pistol, serial no. 21987 with a magazine of five bullets of the same calibre, and one knife in a leather sheath; and
8. Hamdija DELIĆ, son of Ahmo, born 25 May 1972 in Srebrenica, last place of residence in Srebrenica. In addition to his clothes he had a hand grenade, serial no. 7202, and no personal identification papers.

On 23 July 1995 the Bajina Bašta OUP employees handed over the above persons to the members of Bajina Bašta KPDG SM in order to be further handed over to the Republika Srpska state organs because they entered the FRY illegally without valid passports or third country visas. Since these persons were of no interest for further operative processing, they were handed over to the above border control police station and recorded under nos. 28-240/95 and 28-241/95.

Please note that in line with the agreement with the CRDB employees the first six persons were handed over at the Ljubovija border crossing, while SALIHOVIĆ and DELIĆ were handed over at the Bajina Bašta border crossing because they had injured themselves in order to avoid the extradition.
