RECORD
of
transfer of people and items between the Bajina Bašta SM for KPDG
and the Bratunac KPG /border control/ Police Station

At 1700 hours on 24 July 1995, a transfer took place in the general area of the Ljubovija border crossing. The following people who had illegally entered the FRY /Federal Republic of Yugoslavia/, and their possessions, were handed over by the personnel of the Bajina Bašta SM for KPDG to the personnel of the Bratunac KPG Police Station, who took over the people and items:

On this occasion the personnel of the Bajina Bašta SM for KPDG handed over the following to the personnel of the Bratunac KPG Police Station:

1. Fahrudin AVDIĆ, son of Mehmed, born on 28 January 1970 in Osatica, last place of residence in Srebrenica; apart from his clothes he also had a pair of nail clippers and a cigarette case;
2. Mefail RAHMIĆ, son of Suljo, born on 11 January 1969 in Zapolje, Bratunac municipality, last place of residence Srebrenica, apart from his clothes he also had 160 DM /German marks/ in the following denominations: one 50-mark note, four 20-mark notes and three 10-mark notes; ID card number 838/87 issued by the Bratunac SUP /Secretariat of the Interior/ and a driving licence, number 4409, issued by the Bratunac SUP, all in his name;
3. Meho MULALIĆ, son of Refik, born on 29 November 1973 in Ljubovija, last place of residence in Srebrenica; he only had his clothes, no luggage or documents;
4. Ferid HALILOVIĆ, son of Alija, born on 12 August 1966 in Klotijevac, last place of residence Srebrenica; apart from his clothes he also had a gold necklace, a man's gold ring, four small coins with holes drilled at the top, ID card number 1425//illegible/, /?issued by/ the Srebrenica SUP, , a driving licence /illegible/ issued by the Srebrenica SUP, /?a military record booklet no. 181950/, all in his name, and a driving licence no. /?4546/ in the name of Sahib MUHIĆ from /illegible/ and a health insurance card in his name;
5. Muharem HUSIĆ, son of Jahija, born on /?3/ July /?1964/ in Ljubovija, last place of residence Srebrenica; apart from his clothes he also had an ID card number 1175/89 issued by the Srebrenica SUP, an employment record booklet number 695633 in his name, and one 20-DM /German mark/ bill,

6. Nedžib RAHMIĆ, son of Šaban, born on 10 January 1970 in Zapolje, Bratunac municipality, last place of residence Srebrenica; he only had his clothes and no luggage or personal documents.

At 1600 hours on 24 July 1995, according to record no. 28-744/95, the above persons and their possessions were handed over by the personnel of the Bajina Bašta OUP /Department of the Interior/ to the personnel of the Bajina Bašta SM for KPDG, so that they could be transferred to the interior affairs organs of Republika Srpska, since they had illegally entered the territory of the FRY and did not have valid travel documents or visas for travelling to third countries.

The people and items were handed over by Risto ŠEOVAC on behalf of the Bajina Bašta SM for KPDG and taken over by Vidoje RADOVIĆ on behalf of the Bratunac Police Station for KPG /border control/.
